STANDING FOR JUSTICE AND SERVING OUR PROFESSION

A Year in Review

Elections make for busy times, and the 2017 BC provincial election was busier – and longer – than most. The CBABC focused much effort on bringing justice and law reform issues into the campaign arena with our Agenda for Justice containing over 20 proposals for justice improvements. We received much public and media attention on our calls for increased funding for legal aid and for court staffing and infrastructure. We persisted in many media stories, one-on-one conversations with political candidates and in public forums. We made inroads with both the current NDP government and, when it briefly formed a minority government, the Liberals, both promising substantial funding increases. We used this opportunity to exert influence to ensure more people who cannot afford legal services will have assistance to obtain them.

We responded to the Truth and Reconciliation Commission report's calls to action. Working with our Aboriginal Lawyers Forum and Indigenous members, we amended our bylaws so a member of the ALF sits on our Executive Committee and established a working group with a broad cross-section of members to make recommendations on what we should do as an organization, and how we can best assist our members to take action. I believe we will better serve our Indigenous, in fact all members, as a result of this work.

We've had another successful year placing law students into smaller communities though our REAL program, and had meetings with key players in the former and present governments on our student loan forgiveness program for new lawyers in rural communities. We are moving forward with pilot projects in partnership with a couple of communities that we believe will gain government support.



The last goal was to improve governance and service to members. As the CBA nationally continues to transform itself, our Branch will now determine the changes we should make to better govern ourselves and serve you, and we are in the planning stages for a Branch governance review that will bear its fruit in the months ahead. We are a strong Branch, that commands respect from government, the courts and the public, but we can do better and we will.

All said, and due to good work by our member volunteers and staff, we met the marks we set, and that measures up to a successful year.


LAWYER REFERRAL SERVICE & DIAL-A-LAW

The Lawyer Referral Service (LRS) celebrates 62 years of service in the community. This unique service assists British Columbians in locating lawyers for specific types of legal matters. The LRS matches potential clients to members of the LRS panel. Operators refer callers to a participating lawyer who provides an initial consultation of up to 30 minutes for a nominal fee. The purpose of this initial consultation is to find out if there's a legal issue worth pursuing. If both parties agree to proceed with further services, the lawyer's regular rate applies.

Thousands of referrals are made through the LRS each year. Members and non-members of the CBABC may join the service for free. Many LRS lawyers also volunteer to update the Dial-A-Law (DAL) scripts, a library of practical information on various topics of law in BC. Scripts are available to the public by phone or online for free in English, among which some are translated into Punjabi, Chinese and French.

Both programs are operated by CBABC and funded by the Law Foundation of BC.

LEARNING & NETWORKING

PROFESSIONAL DEVELOPMENT

CBABC Professional Development hosted 31 programs this term, 13 of which were hosted as webinars and are currently available for repeat purchases. The CBABC joined with your Local County Bar Associations, CBABC Sections, and independently held seminars, webinars, and full and multi-day conferences, producing 101.75 hours of substantive CPD, 40 hours of which counted towards your required ethics, professional responsibility and practice management component.

CBABC's highly popular two-part series High Conflict Clients dealt with how to identify demanding clients, how to understand their needs, how to cope with their demands, how to remove yourself from the file, how to fire a client and still maintain your professional obligations to the client.

The CBABC joined with the Alberta Branch this year to bring you the highly successful CBA West Conference in Las Vegas. Attended by 200 people, speakers and guests alike gathered, networked, and socialized with colleagues and leaders in the legal profession from across Canada. Twelve sessions provided an opportunity to hear from leading practitioners on emerging legal issues featuring a range of experts from Alberta, BC and the US.

As one attendee said, *"Venue was terrific, excellent speakers, lots of free time, and dinner on Saturday was a great experience."*

SECTIONS

Exclusive to CBA members, Sections are practice-focused groups organized by substantive areas of law while Forums are organized by interest areas. Both are great opportunities to network and attain the required continuing professional development hours. BC Advantage offers CBABC members unlimited access to 76 BC Sections and 41 National Sections.

2016/2017 was a successful term producing many well attended events, seminars, and conferences. 472 Section Executive Officers volunteered their time this term in order to support the highly active 75 Sections, with 20,689 Section enrollments taking place.

This year 3,964 enrolled members attended 358 Section meetings/events: 183 of these meetings were offered both in-person and remote participation options, 163 by webinar and 20 by teleconference. Throughout the course of the term, the CBABC awarded 347 continuing professional development (CPD) hours in accredited educational activities for the 2017 LSBC Reporting year.

CELEBRATING #CHARTER35

Every April, Law Week celebrates the anniversary of the signing of Canada's Charter of Rights and Freedoms. 2017 was the 35th anniversary and brought BC's legal community together to raise awareness of the justice system and promote access to justice around the province. 2017 Law Week events included BC judges in high school classrooms, free public legal education classes and family-friendly community events in Fort St. John, Kelowna, Terrace, Nelson, Victoria, Penticton, Vancouver and Kamloops.

DIAL-A-LAWYER DAY

Dial-A-Lawyer Day is the highlight of Law Week, offering free legal advice to the public. Volunteer lawyers go to work on a Saturday at the CBA BC Branch office to answer phone calls and give free legal advice. In 2017, Dial-A-Lawyer Day welcomed 20 volunteer lawyers who answered a record 325 calls – 15% more calls than the year before. The vast majority of callers needed Family Law advice and learned about Dial-A-Lawyer Day through CBABC promotion in province-wide media.

MEET THE CHIEFS

A lucky group of high schoolers attended "Meet the Chiefs", a student forum offering the chance to meet and speak with BC's Chief Justices, and ask questions about BC's judicial system. The session welcomed Chief Justice Christopher Hinkson (BC Supreme Court), Madam Justice Mary Saunders (BC Court of Appeal) and Chief Judge Thomas Crabtree (BC Provincial Court). Students asked about important legal issues and the Chiefs offered direct responses to hard-hitting questions. "Meet the Chiefs" was at CBC's Vancouver studios and moderated by anchor Ian Hanomansing.

BARRY SULLIVAN LAW CUP

The Barry Sullivan Law Cup is a BC-wide public speaking competition for Grade 10, 11 & 12 students who compete by speaking on a specific legal topic. Finalists deliver their speeches at the heritage courtrooms in the Vancouver Art Gallery. The speeches were judged by representatives of BC's Supreme Court, BC's Provincial Court and UBC.

The 2017 winner was Kalith Nanayyakara of Johnston Heights Secondary School in Surrey. Here, Kalith accepts the Barry Sullivan Law Cup, with Barry Sullivan's family, from Bill Veenstra, CBABC then-Vice President.
