Arlene Huggins of Toronto, the Chair of the Standing Committee on Equity, seconded Kerry's motion. Arleen explained to Council that the mandates of the Equity Committee and the Women Lawyers Forum are complementary, not overlapping. Other speakers in favour of the motion included Parker McCarthy, Q.C. (Second Vice-President of the CBA, National) and Meg Shaw (Vice President of the British Columbia Branch of the Canadian Bar Association).

The first meeting of the National Women Lawyers Forum will take place in Vancouver in conjunction with the Canadian Legal Conference (August 14-16 at the Vancouver Convention Centre).

The Mentoring Project is now full and we are no longer accepting new applications for 2005 year. Project participants have committed to a one-year term. A celebration will be held at the end of the year to mark the project's success and new friendships that were formed during the year. We will welcome new applicants for the 2006 year starting in September 2005.

**Guidelines:** The Mentoring Committee has prepared guidelines that detail the goals of the Mentoring Project, the role of the Mentoring Committee, the scope of the mentoring relationship and other issues such as confidentiality. Each mentoring pair has also signed an Agreement, specifying terms of the mentoring relationship, expectations, confidentiality, and includes a waiver of liability.

**Events:** In December 2004, a celebration was held with the participation of mentors and mentees in the Sutton Place Hotel. Live music and personal stories from successful mentoring relationships were the highlight of the event.

On March 15 we held an orientation for mentors and mentees at the Sutton Place Hotel. The lunch orientation was very well attended, and participants were very enthusiastic about the project. There was a fairly even mix of mentors and mentees. Some of the mentor/mentee matches met each other for the first time while others had already met or spoken on the telephone.

On April 7, we will hold a mentor/mentee training session at Blake Cassels and Graydon's offices on a "bring your own lunch" basis. The training session is titled: "Mentoring Effectively – Communication Tips for Mentors and Mentees"; the presenters will be Deb Zutter and Anne Chopra.
