## Comments from the Chair

I am pleased to introduce the CBABC Women Lawyers Forum (WLF) Newsletter. This newsletter, (which we hope to publish on a regular basis), is intended to inform our members of past and upcoming WLF activities, promote the objectives of the WLF, and otherwise communicate why your ongoing support of the WLF is so important to our ability to achieve those objectives.

The purpose of the WLF is to promote, support and advance the stature and influence of women in the legal profession. Key to achieving that mission is providing opportunities to develop, build, and promote networks for women lawyers – hence the WLF's mission statement "Connecting Women in the Law". WLF members include lawyers in all sizes of law firms from sole practitioners to national firms, in government, and in the private sector. We strive to offer something for lawyers at all stages of their professional careers, whether you are law or articling students, senior practitioners and everything in between including those lawyers who are looking to return to practice after some time away.

The WLF supports its mission through a number of events each year, organized around mentoring, education, networking and recognition. Last fall, we were particularly busy organizing eight events. We kicked off our program year in September 2009 with our annual "Ten Hot Tips From Ten Hot Mentors" evening at the Law Courts Inn, featuring presentations from an impressive line-up of senior practitioners. So far this year the WLF has sponsored four networking events – two potluck dinners held at the homes of Kerry-Lynne Findlay, QC (fall) and Diane Bell (spring), two outreach lunches held in Langley and Richmond, and two senior women lawyer dinners with retired Justice Mary Southin and May Brown as honoured guests.

In the Fall, we were pleased to be involved in an evening sponsored by the Law Society to hear from three members of the Law Society's Task Force about their Report on the Retention of Women in the Practice of Law, which was published earlier in the year. Finally, our Mentoring Committee has recently matched 178 lawyers - the highest number ever – for the WLF's 2010 Mentoring Program.

I was particularly happy to be invited last year to work with the Law Society Education Committee to discuss whether mentoring should be eligible for Continuing Professional Development (CPD) credits. Drawing on the WLF's seven years of experience working with over 600 women in our Mentoring Program, I was able to discuss the value that lawyers, at all stages of their career, can receive from a colleague's guidance. Starting in January 2010, the Law Society has agreed that CPD credits can be earned for mentoring activities, including the WLF's Mentoring Program.

One of the highlights of 2009 was the WLF's second Awards Luncheon where Award of Excellence recipient Kathryn Berge, QC was recognized, and where we presented our first Debra Van Ginkel, QC Mentoring Award to Brenda Edwards. This luncheon, attended by more than 180 lawyers, also featured an inspiring speech by Carole Taylor on the topic of success for women in business and politics.

None of these events and efforts would be possible without the many volunteer hours put in by the 16 lawyers who sit on the WLF Executive, or the many other lawyers who sit on one of our four committees. We encourage you to contact any of us on the executive, if you are interested in volunteering your time on our Mentoring, Public Relations, Education, or Events Planning committees.



Finally, the WLF is always looking for new ways to connect with women lawyers so we encourage you to contact any member of the Executive with your ideas regarding issues you believe the WLF should consider, or speakers or other resources that you recommend to support our mission. ## Mentoring Committee

January 2010 marked the start of this year's Mentoring Program. Proof that the awareness and understanding of the importance of mentoring to career success, is the fact that the WLF's mentoring committee received an overwhelming number of applications from prospective 'mentees'. This then resulted in the mentoring committee making a targeted plea to senior women lawyers around BC to stand as mentors. Senior women lawyers responded to our call in numbers that exceeded our need, thereby allowing the Committee to match 86 mentor-mentee pairs (the "Pairs") in January.

After the matches were made, the first Mentoring event - an Orientation Luncheon - took place on February 10, 2010. The Pairs met for the first time to get to know each other, review and sign the mentoring contract, and to learn how mentors and mentees can qualify and apply for CPD credits with the Law Society. Note: If Pairs were not able to attend, the Orientation program can be viewed from your computer by going to the Women Lawyers Forum part of the CBABC website (under Mentoring).

The mentoring committee then hosted an event called the *Art of Communication*, on April 14, 2010 at the Law Courts Inn. This interactive event provided a great opportunity for the Pairs to spend time together and engage in real exercises learning practical skills for communication and mentoring, and otherwise getting the most out of their year in the program.

The mentoring committee also sponsors the annual *Ten Hot Tips from Ten Hot Mentors*, held in September of each year. This event has proven to be one of the WLF's most popular events, and last September's event was no exception. The popularity of this annual event is in large part due to the quality of the presentations from the many senior women lawyers who have so generously shared their experiences. Most great leaders are not born that way—they will usually tell you that leadership is learned by watching other leaders in action, through education, and by trial and error.

Ethics and ethical behaviour is at the core of how we as lawyers conduct ourselves and advance our clients’ interests. Understanding your own values, and learning to trust your instincts is as important as knowing the Professional Code of Conduct and Law Society Rules. As lawyers, we are often faced with decisions on how best to advance our clients’ interests while still conducting ourselves ethically and professionally.

We have brought together a group of outstanding women who are well qualified to discuss both topics. By sharing their stories of experiences (both good and bad), and allowing for group discussion of the panel presentations, with time for the all important Q & A, we expect the Education Day will provide an exceptional learning opportunity for attendees.
